### **Attachment 1: Research residence permit code**

Wageningen University/Research is a recognised sponsor at the Dutch Immigration Authority (IND). This position enables the host organisation to apply for the researcher's residence permit. The host organisation applies for a research residence permit in accordance with EU guideline 2016/801 for the researcher. [Expat Center Food Valley / PhD Services] will apply for the residence permit on behalf of the host organisation.

The research residence permit has specific requirements which the researcher has to meet during the entire duration of the residence permit:

- The researcher has to perform scientific research as described in the hosting agreement.
- The researcher's main location of residence has to be in the Netherlands. This means that:
  - The researcher has to be registered as a resident at the municipality office of the Dutch municipality where the researcher lives.
  - The researcher may not stay outside the Netherlands for more than 4 months per year during three consecutive years or 8 months during one year.
- The researcher has to meet the residence permit's minimum income requirement.
  - Researchers financing their living expenses by their private financial means must participate in an annual income check performed by [Expat Center Food Valley / PhD Services]
- Upon arrival in the Netherlands the researcher has to undergo a
  medical examination for tuberculosis; unless the researcher has
  a nationality which is exempted from this requirement. All

- The researcher has to have an insurance covering medical expenses in the Netherlands.

The residence permit enables the researcher to live and work in the Netherlands as a scientific researcher. In addition to this the researcher has access to the Dutch labour market for other employment, as long as the researcher continues to perform scientific research as agreed upon in the hosting agreement.

The residence permit also enables the researcher to travel to other Schengen countries for a maximum of 90 days per 180 days. Note that the aforementioned limitation of 4 or 8 months per year outside the Netherlands also applies to Schengen countries, except for research visits under the EU guideline 2016/801 EU Research Mobility.

An appeal for <u>public funds</u> (for example "<u>bijstand</u>" unemployment benefits") may lead to the termination of the residence permit.

[Expat Center Food Valley / PhD Services] will inform the researcher on the type of healthcare insurance the researcher has to obtain.

Depending on the researcher's situation this may be a Basic Healthcare Insurance or an AON Complete + insurance.

The researcher has to leave the Netherlands before the end date of the residence permit, unless an extension of the residence permit, or a new residence permit is being applied for prior to the end date of the current residence permit.
